ORDINANCE NO. 2021-04

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DINUBA AMENDING THE ZONING ORDINANCE PERTAINING TO LANDSCAPE STANDARDS AND THE DINUBA LANDSCAPE DESIGN GUIDELINES

THE CITY COUNCIL OF THE CITY OF DINUBA HEREBY DOES ORDAIN:

SECTION 1. FINDINGS.

- (a) The City of Dinuba administers a Zoning Ordinance that includes standards for the installation and maintenance of landscaping associated with new development projects.
- (b) The landscaping standards are intended to ensure that development is attractive and enhances the community, while conserving water resources.
- (c) The City has prepared the Dinuba Landscape Design Guidelines to augment the ordinance and improve its effectiveness.
- (d) The Dinuba City Council finds that there is a need to incorporate references to the Landscape Design Guidelines to ensure that both ordinance and guidelines are integrated and work together.

SECTION 2. Amendments were made to Title 17 (Zoning) and are shown in Attachment “A” of this Ordinance. Text additions are shown in **bold underline** format. Text deletions are shown in ~~strikeout~~ format.

SECTION 3. SEVERABILITY.

Each of the provisions of this ordinance is severable from all other provisions. If any article, section, subsection, paragraph, sentence, clause or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance.

SECTION 4. The City Clerk is hereby directed to cause a summary of this Ordinance to be published by one insertion in a newspaper of general circulation in the community at least five (5) days prior to adoption and again fifteen (15) days after its adoption. If a summary of the ordinance is published, then the City Clerk shall cause a certified copy of the full text of the proposed ordinance to be posted in the office of the City Clerk at least five days prior to the Council meeting at which the ordinance is adopted and again after the meeting at which the ordinance is adopted. The summary shall be approved by the City Attorney.

This Ordinance shall take effect and be in full force thirty (30) days from and after its adoption.

ORDINANCE NO. 2021-04

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DINUBA AMENDING TITLE 17
OF THE DINUBA MUNICIPAL CODE RELATING TO LANDSCAPE DESIGN GUIDELINES**

The City Council of the City of Dinuba does hereby ordain as follows:

Section 1. Subsection 17.20.130 R (One Family Residential Districts (Landscaping)) is amended as follows:

17.20.130 Landscaping

All uses in the R district shall have landscaping installed in the required front yard including irrigation, plants and ground cover within six months of occupancy. **All landscaping shall be consistent the Dinuba Landscape Design Guidelines.**

Section 2. Subsection 17.24.160 RM Multifamily Residential Districts (Landscaping) is amended as follows:

17.24.160 Landscaping.

All multiple-family developments in the RM districts shall have landscaping including irrigation, plants and groundcover which are installed in accordance with a plan approved by the city. Landscape and irrigation plans shall be submitted to and may be approved by the city staff prior to installation and occupancy of use based upon the standards set forth in this section. If city staff does not approve a landscape and irrigation plan, that decision may be appealed in the same manner as is set forth for Section [17.80.080](#); however, notices are required to be sent to parties other than the owner of the site only in the event of disapproval of the plan. The purpose of this section is to establish standards for the installation of landscaping, including irrigation, plants, trees and groundcover, around multifamily dwellings in order to enhance aesthetic appearance, improve compatibility between land uses, conserve water, control soil erosion and enhance the character of existing neighborhoods.

~~A. Plant Location.~~

- ~~1. All required setbacks shall be landscaped with live plants except the walkways, driveways, parking areas and patio areas. Landscaping bordering such areas is encouraged. Nonorganic groundcover shall not be used in place of plant material in planter areas unless utilized as a decorative accent.~~
- ~~2. Plants shall be grouped according to similar water needs.~~
- ~~3. Plants shall not interfere with safe sight distances or otherwise block vehicular, bicycle or pedestrian traffic, or conflict with the installation, maintenance, or repair of any public utility.~~
- ~~4. A planting area a minimum of four feet in width shall separate a building from a driveway or parking area as feasible.~~
- ~~5. Parking lots shall be separated from street frontages and from abutting uses by planting areas. In addition, planting areas shall be interspersed among the parking stalls as feasible, including provision of trees for appearance and shade.~~

~~B. Plant Type.~~

- ~~1. Drought-tolerant plants shall be used where feasible.~~
- ~~2. Plants shall complement the architectural design of structures on the site, and shall be suitable for the soil and climatic conditions specific to the site.~~

~~C. Plant Size.~~

- ~~1. Plants shall be sized and spaced to achieve immediate effect and shall normally not be less than a fifteen-gallon container for trees, five-gallon container for shrubs, and a one-gallon container for mass planting. Groundcover coverage must be one hundred percent in one year, with rooted cuttings from flats planted no more than twelve inches on center and containerized woody, shrub ground cover planted no more than three feet on center.~~
- ~~2. Landscape plans shall incorporate existing mature trees with trunk diameters of six inches or greater that are compatible with the proposed grades, structures and hardscape. Specimen trees, fifteen-gallon or larger, may be used to replace an existing mature tree that cannot feasibly be saved.~~

~~D. Planting Areas.~~

- ~~1. All planting areas shall be served by a permanent underground automatic, timed, water efficient irrigation system. A drip irrigation system or other water conserving irrigation system may be required where feasible.~~
- ~~2. A six inch high stone masonry or concrete curb shall be placed between any paved area and a landscaped area to prevent erosion.~~

~~E. Landscape Coverage.~~

- ~~1. The landscape coverage of the entire site shall be a minimum of ten percent.~~
- ~~2. Approved street trees shall be planted along street frontages in accordance with the city of Dinuba street tree master plan.~~

A. ~~F.~~ Landscape and Irrigation Plans Required. A landscape plan and irrigation plan shall be submitted in accordance with Chapter [17.80](#).

B. **All landscaping shall be consistent with the Dinuba Landscape Design Guidelines.**

Section 3. Subsection 17.32.130 (PO Professional Office District (Landscaping)) is established as follows:

17.32.130 Landscaping.

New developments shall provide landscaping in all yard areas abutting public streets, consistent with the Dinuba Landscape Design Guidelines.

Section 4. Subsection 17.40.040 (C-1 Neighborhood Commercial District) is amended as follows:

17.40.040 Screening and landscaping—Fences, walls and hedges.

In the C-1 district:

- A. Where a site adjoins or is located across a street or alley from any residential district, an ornamental solid wall or fence, six feet minimum in height, or such other

height or type of screening device as may be required by the city, shall be located on the property line common to such districts, except in a required front yard.

- B. Open storage of materials and equipment attendant to a permitted use or conditional use shall be permitted only within an area surrounded or screened by a solid wall or fence six feet minimum in height, except as may be modified under site plan review. Said storage shall not be visible above said fence or wall.

~~C. Street trees and other forms of landscaping may be required under the provisions of Chapter [17.71](#).~~

Section 5 Subsection 17.40.100 (C-1 Neighborhood Commercial District (Yard-Front) is amended as follows

Section 17.40.100 Landscaping is amended as follows:

17.40.100 Yard—Front.

Where a lot or lots in a C-1 zone are located in the same block as, and have a common frontage with, a lot or lots in any residential district, the minimum front yard depth of such lot or lots in such portion of such C-1 zone shall be a minimum of fifteen feet. ~~An average of ten feet of the required front yard shall be landscaped.~~ **All front yard areas shall be landscaped consistent with provisions of the Dinuba Landscape Design Guidelines.**

Section 6 Subsection 17.40.160 (C-1 Neighborhood Commercial District (Landscaping) is added, as follows:

17.40.160 Landscaping.

All new development shall provide landscaping consistent with the Dinuba Landscape Design Guidelines.

Section 7 Subsection 17.42.040 (C-2 Downtown Commercial District (Screening and landscaping—Fences, walls and hedges.) is amended as follows:

17.42.040 Screening and Landscaping – Fences, Walls and Hedges

In the C-2 district:

- A. Where a site adjoins or is located across a street or alley from any residential district, an ornamental solid wall or fence, six feet minimum in height, or such other height or type of screening device as may be required by the city, shall be located on the property line common to such districts, except in a required front yard.
- B. Open storage of materials and equipment attendant to a permitted use or conditional use shall be permitted only within an area surrounded or screened by a solid wall or fence six feet minimum in height, except as may be modified under site plan review. Said storage shall not be visible above said fence or wall.
- C. ~~Street trees and other forms of landscaping may be required under the provisions of Chapter 17.71.~~ **Landscaping shall be provided consistent with the Dinuba Landscape Design Guidelines.**

Section 8 Subsection 17.42.100 C-2 Downtown Commercial District (Landscaping) is amended as follows:

17.42.100 Yard—Front.

Where a lot or lots in a C-2 zone are located in the same block as, and have a common frontage with, a lot or lots in any residential district, the minimum front yard depth of such lot or lots in such portion of such C-2 zone shall be a minimum of fifteen feet. ~~A minimum of fifty percent of the required front yard shall be landscaped.~~ **Front yards shall be landscaped consistent with the Dinuba Landscape Design Guidelines.**

Section 9 Subsection 17.44.090 (C-3 Community Commercial District (Yard requirements) is amended as follows:

17.44.090 Yard Requirements

Yard requirements in the C-3 district are as follows:

- A. The minimum front yard shall be fifteen feet **and shall be landscaped consistent with the Dinuba Landscape Design Guidelines**. ~~An average of fifty percent of the required front yard shall be landscaped.~~
- B. Except as specified in subsections (B)(1) and (2) of this section, no side yards or rear yards shall be required:
 - 1. The minimum side yard abutting any residential or PO district shall be ten feet and shall be landscaped **consistent with the Dinuba Landscape Design Guidelines**
 - 2. The minimum rear yard abutting any residential or PO district shall be ten feet and shall be landscaped **consistent with the Dinuba Landscape Design Guidelines**.

Section 10 Subsection 17.46.090 (C-4 General Commercial District (Yard Requirements)) is amended as follows:

17.46.090 Yard requirements.

Yard requirements in the C-4 district are as follows:

- A. The minimum front yard shall be fifteen feet **and shall be landscaped consistent with the Dinuba Landscape Design Guidelines**. ~~A minimum of fifty percent of the required front yard shall be landscaped.~~
- B. Except as specified in this subsection, no side yard or rear yards shall be required.
 - 1. The minimum side yard abutting any residential or PO district shall be ten feet and shall be landscaped **consistent with the Dinuba Landscape Design Guidelines**.
 - 2. The minimum rear yard abutting any residential or PO district shall be ten feet and shall be landscaped **consistent with the Dinuba Landscape Design Guidelines**.

Section 11 Subsection 17.50.140 (M-1 Light Industrial District (Landscaping) is established as follows:

17.50.140 Landscaping

All setback areas abutting public rights-of-way shall be landscaped consistent with the Dinuba Landscape Design Guidelines.

Section 12 Subsection 17.52.140 M-2 Heavy Industrial District (Landscaping) is established as follows:

17.52.140 Landscaping

All setback areas abutting public rights-of-way shall be landscaped consistent with the Dinuba Landscape Design Guidelines.

Section 13 Subsection 17.63.020 D (Property Development Standards) is amended as follows

17.63.20 Yards

D. Yards.

1. All yards required by the underlying zone district and abutting a street shall be landscaped and maintained, **consistent with requirements of this title and the Dinuba Landscape Design Guidelines.**

Section 14 Subsection 17.64.070 Offstreet Parking and Loading (Landscaping) is amended as follows

17.64.070 Landscaping requirements.

The submission of any plan for off-street parking facilities shall be accompanied by a detailed landscape plan as part of the permit review process. All off-street parking facilities shall conform to the landscaping standards identified in Chapter 17.71 **and consistent with the Dinuba Landscape Design Guidelines.** In addition, all off-street parking facilities shall conform to the following requirements:

- A. The project plot plan shall indicate the location of all landscaping.
- B. Not less than six percent of a parking lot comprising up to twenty parking spaces shall be landscaped and continuously maintained.

- C. Not less than ten percent of a parking lot comprising more than twenty parking spaces shall be landscaped and continuously maintained.
- D. Not more than ten consecutive parking stalls shall be allowed without an approved landscaped tree well of twenty square feet or more.
- E. A planting list shall be shown on the required plot plan to obtain a grading permit, or building permit, for the buildings for which the parking lot is provided. The planting list shall give the botanical and common names of the plants to be used, the sizes to be planted, the quantity of each and the spacing to ensure balance and design.
- F. The director shall approve all landscaping plans within a parking area and shall have the right to require additional landscaping if he deems it necessary to improve the aesthetic character of the project.

Section 15 Subsection 17.70.055 K Mobile Home Parks (Development Standards (Landscaping and Screening)) shall be amended as follows:

17.70.055 K. Landscaping and Screening.

Mobile home parks shall provide permanently maintained landscaped areas and site screening **consistent with these standards and the Dinuba Landscape Design Guidelines**, as follows:

- 1. A landscaped border along the entire street frontage yard area and along the rear yard if such yard is adjacent to a public street;
- 2. Ornamental screen wall or fencing, six feet in height, along all interior side property lines and along all rear property lines which do not abut a public street;
- 3. Ornamental screen wall or fencing six feet in height along street side yard and street front yard setback lines.

Section 16 Subsection 17.71.130 Special Provisions and Development Standards (Landscaping)) is amended as follows:

17.71.130 Landscaping.

- A. Whenever this zoning title requires landscaping, the following standards of design installation and maintenance (**along with compliance with the Dinuba Landscape Design Guidelines**) shall be observed:

1. When property is undeveloped at the time landscaping requirements are imposed upon the property, all required landscaping shall be provided and maintained prior to the time a main building is occupied for any use requiring a building or when any open use, other than agricultural, occurs on the property.
2. All vegetation shall be provided with an adequate, permanent and nearby source of water by means of installed on-site water sprinklers or a flood irrigation system. The irrigation system shall be designed to irrigate all plant material and to supply adequate on-site water to grow healthy plants under Dinuba's climatic conditions. The irrigation plan shall indicate the type of heads, pipe size, valve size, backflow valve and water supply size and source.
3. Landscaping provided in conjunction with any use requiring a site plan shall be generally designated on the site plan. Prior to the issuance of any building permit, a detailed landscape planting, irrigation and grading plan (when a landscape mound is proposed) shall be submitted to a scale of not less than one inch equaling forty feet, which shall show the location, size and variety of all plantings, water supply, contours and similar designations as the director may require.
4. All vegetation shall be maintained free of physical damage or injury from lack of water, excess chemical fertilizer or other toxic chemical, or disease, and any such vegetation which shows signs of such damage or injury shall be replaced by the same or similar vegetation of a size and character which will be comparable at full growth.
5. Landscaping shall be kept free from weeds and undesirable grasses.
6. Every property owner or occupant shall be responsible for the maintenance and care of all trees, shrubs, plants and vegetation in the street right-of-way abutting such property.
7. Planting. Except for driveways and as otherwise provided by this title, all required yards shall be landscaped. Each residential parcel of land or lot shall have a minimum of one medium-sized tree for each residential unit. Each commercial and industrial parcel of land or lot shall have a minimum of one medium-sized tree for every two parking spaces. Two small trees (fifteen to thirty feet at maturity) shall be counted as one medium-sized tree. All present and future tree planting and shrub planting shall conform to the requirements of the city.
8. Parking Lot Shading. The following provisions shall apply in all PO and C districts as well as the PA overlay district:
 - a. For new uses, fifty percent of paved parking lot surfaces shall be shaded by tree canopies within fifteen years of planting. This requirement may be reduced for existing development if it is demonstrated that the constraints of an existing site would make it impossible to meet the normal standard. The requirement for

parking lot shading for existing development shall apply if new construction or remodeling results in an addition of two thousand five hundred square feet or more. The amount of shading required for existing development shall be determined during the site plan review process but shall be in keeping with the intent of the section.

- b. A “paved parking lot” shall include parking stalls, driveways and maneuvering areas.
- c. Trees planted to satisfy the requirements of these guidelines are subject to established landscaping requirements as identified in subsection (A)(7) of this section. This requirement may be waived if the standards for shading have been met.
- d. A landscaping plan which details the degree of compliance with the parking lot shading is required. The plan shall show:
 - i. All landscaped areas;
 - ii. Tree canopies drawn to scale representing the estimated canopy at a fifteen-year growth period;
 - iii. The total area in square feet of the paved parking lot, driveways and maneuver areas and the area shaded by tree canopies. A schedule listing total parking area, shaded area and the percentage of parking area shaded should be included;
 - iv. A schedule of the specific names of proposed trees and their sizes.
- e. To simplify the process of determining compliance, the true angle of deflection of natural sunlight shall not be considered. Shaded areas shall be assumed to be only those portions of a paved parking lot directly beneath the shading canopy or drip line.
- f. Any portion of a paved parking lot shaded by a manmade structure (overhangs and covered parking for instance) shall be subtracted from the area of the parking lot to be shaded.
- g. Trees planted along the perimeter of a lot may be counted as providing shade for the full area of their canopy.
- h. If the degree of overlap between trees is less than fifteen percent, all trees may be counted as shading one hundred percent of their canopy. If the degree of overlap is fifteen percent or greater, then it will be necessary to perform individual calculation to determine the area of shading.

- i. A ten percent minor deviation of the shading standard may be approved by the director if it is found that the normal standards would impose an undue hardship.
- 9. The director may allow minor deviations from a landscape site plan.
- 10. The updated Model Water Efficient Landscape Ordinance, Sections 490-495, Chapter 2.7, Division 2, Title 23 in the California Code of Regulations, which may be referred to in this code as the MWEL, as promulgated by the California Department of Water Resources, as may be amended, is hereby adopted and incorporated by reference into the code. One copy of the MWEL is on file and available for use by the public in the city of Dinuba public works department.
- B. Whenever any person neglects to conform to this title, or a site plan concerning any landscaping or landscaped area, the director may require, upon thirty days' written notice, such compliance. In the event noncompliance continues, in whole or in part, the director may cause work to be done and plantings to be made to bring the landscaping or area into compliance. The work and plantings and a lien therefor shall be accomplished as provided for in the Dinuba Municipal Code. (Ord. 2017-03 § 2 (part), 2017: Ord. 2008-05 § 1 (part), 2008: Ord. 93-6 § 3 (part), 1993. Formerly 17.71.140)

Section 17 Subsection 17.82 C. Design Guidelines (Landscaping) is amended as follows:

17.82 C. Landscaping

- C. Landscaping **shall be consistent with the Dinuba Landscape Design Guidelines.** ~~should be included in any project design to create a pleasing appearance from both within and off the site. Site landscaping should be utilized to promote the character of the city, particularly as demonstrated by large shade trees.~~
 - ~~1. Landscape and Irrigation Plans Required. A landscape and irrigation plan drawn to scale and dimensioned shall be submitted to the development services division for all new projects in all nonresidential zones, and for all new residential projects of two or more units.~~
 - ~~a. Landscape Plan Contents. A landscape plan shall contain at a minimum the following information:~~
 - ~~i. List of plants (common and botanical names) with water use classification, according to the latest Water Use Classification of Landscape Species (WUCOLS).~~

- ~~ii. Plant Size. Trees shall be a minimum of fifteen gallon size and shrubs a minimum of five gallon size, when available.~~
 - ~~iii. Plant location, with size and type identification.~~
 - ~~iv. Location of existing trees with a trunk diameter of six inches or greater.~~
 - ~~b. Irrigation Plan Contents. An irrigation plan shall contain at a minimum the following information:~~
 - ~~i. Location, type and size of lines.~~
 - ~~ii. Location, type, gallonage output, and coverage of heads and emitters.~~
 - ~~iii. Location and size of valves.~~
 - ~~iv. Location and type of controller, with all sensors listed.~~
 - ~~v. Location and type of backflow prevention device.~~
 - ~~vi. Available water pressure, water meter outlet size, and flow rates at meter.~~
- ~~2. Maintenance of Landscape. Planting areas shall be permanently maintained, including watering, weeding, pruning, trimming, edging, fertilizing, insect control, and replacement of plant materials and irrigation equipment as needed to preserve the health and appearance of plant materials. All trees, shrubs, and plants which, due to accident, damage, disease, or other cause, fail to show a healthy growth shall be replaced. Replacement plants shall conform to all the standards which govern the original planting installation.~~
- ~~3. Landscaping for commercial, industrial and multifamily uses shall be irrigated with an automatic, timed irrigation system.~~
- ~~4. Native and mature trees and vegetation shall be retained and integrated.~~
- ~~5. Landscaping should be planned as an integral part of the project and not simply located in leftover space after parking and building siting.~~
- ~~6. Street trees shall be installed in accordance with the city street tree master plan.~~
- ~~7. Dense landscaping shall be installed to screen unattractive views and features such as storage areas, trash enclosures, and transformers.~~
- ~~8. Landscaping within and adjacent to parking areas shall be provided to screen vehicles from view and minimize the expansive appearance of parking areas.~~

- ~~9. Deciduous trees along the south and west building exposures shall be encouraged.~~
- ~~10. Ground cover shall be of live plant material. Gravel, colored rock, bark, and similar materials shall be limited to twenty five percent maximum.~~
- ~~11. Landscaping shall permit adequate sight distance for motorists and pedestrians entering and exiting the site.~~

**RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF DINUBA**

(Government Code section 21156)

WHEREAS, the City of Dinuba (hereinafter referred to as Agency) is a contracting agency of the California Public Employees' Retirement System (CalPERS);

WHEREAS, the California Public Employees' Retirement Law requires that a contracting agency determine whether an employee of such agency in employment in which he is classified as a local safety member is disabled for purpose of the California Public Employees' Retirement Law and whether such disability is "industrial" within the meaning of such law;

WHEREAS, an application for industrial disability retirement of the lower back and cumulative injury from Jaime Lopez employed by the Agency in the position of Police Officer has been filed with CalPERS; and

WHEREAS, the City Council has reviewed the medical and other evidence relevant to such alleged disability;

NOW, THEREFORE, BE IT RESOLVED that the City Council find and determine and it does hereby find and determine that Jaime Lopez is incapacitated within the meaning of the California Public Employees' Retirement Law for performance of his duties in the position of Police Officer and does hereby certify under penalty of perjury that this determination was made on the basis of competent medical opinion and was not used as a substitute for the disciplinary process in accordance with Government Code section 21156(a)(2). If the disciplinary process occurred before the member's separation from employment, all relevant personnel documents were forwarded to CalPERS for determination of the member's eligibility for disability retirement and CalPERS' determination that the member is eligible to apply for disability retirement was obtained prior to starting the process of determination.

Jaime Lopez had filed a Workers' Compensation claim for his disabling condition. The Workers' Compensation claim was accepted.

BE IT FURTHER RESOLVED THAT the City Council find and determine and it does hereby find and determine that such disability is result of injury or disease arising out of and in the course of employment.

Neither said Jaime Lopez nor the agency, City of Dinuba has applied for the Workers' Compensation Appeals Board for a determination pursuant to Government Code section 21166 whether such disability is industrial.

BE IT FURTHER RESOLVED that the member will be separated from her employment in the position of Police Officer after expiration of his rights under Government Code section

21164, effective October 31, 2021 and that no dispute as to the expiration of such leave rights is pending. His last day on pay status is October 31, 2021.

There is not a possibility of third party liability.

Advanced Disability Pension Payments will not be made.

The primary disabling conditions is right hand and wrist.

The duration of the disabling condition is expected to be permanent, which is certified by competent medical opinion, as determined on the basis of competent medical opinion.

Avila stated that organic waste makes up more than 50 percent of waste in the State of California. This mandate expands on current mandates and requires all disposal customers to reduce organic waste by 70% by 2025. State will allow education outreach in order for individuals to comply by January 1, 2024. City will work with Pena's Disposal to meet the compliance for all customers. The new ordinance for SB1383 will be included in the previously adopted recycling ordinance.

The City will include an insert in the October, November and December utility billing and on social media to educate the community. Vice Mayor Reynosa asked if multi-family units were required to comply and Art Pena advised that multi-family units must also comply.

RECOMMENDATION

Council conduct a public hearing and following the hearing adopt Resolution No. 2021-49 authorizing expenditure of the 2021 Citizens Option for Public Safety (COPS) Grant funds in the amount of \$100,000.

EXECUTIVE SUMMARY

Every year the Citizens Option for Public Safety (COPS) Grant is funded through AB 3229 and allocates \$100,000 to offset the cost of one police officer position. The funds are dispersed through the Tulare County Auditor-Controller in a Supplemental Law Enforcement Services Fund (SLESF). The Dinuba Police Department has been awarded this grant for the past twenty-four years.

OUTSTANDING ISSUES

None.

DISCUSSION

The Citizens Option for Public Safety (COPS) Grant will assist the department in providing funds to offset the cost of one full-time police officer. The total cost of a full-time officer is \$141,763. The COPS grant will offset \$100,000 of the officer's salary and benefits with the remaining \$41,763 being charged to the general fund.

The COPS grant requires the City to conduct a public hearing each year to solicit community input on the use of grant funds. Again, the City has utilized the COPS grant to fund one full-time police officer. However, the City Council may choose to allocate the COPS grant funds for other uses based on community input.

FISCAL IMPACT

The total cost of a full-time police officer's salary with benefits is \$141,763. The remaining \$41,763 will be absorbed by the department's budget.

PUBLIC HEARING

A notice of the public hearing was published in the Mid Valley Times on Thursday, September 30, 2021.

RECOMMENDATION

Council to adopt Resolution No. 2021-50 authorizing the submittal of a grant application up to \$3 million to the Rural Recreation and Tourism Program Grant program for the Ridge Creek Pedestrian and Bike Interpretive Trail.

EXECUTIVE SUMMARY

The state Rural Recreation and Tourism Grant Program, which is funded by the Proposition 68 (2018 Bond Act), is accepting applications for projects that create new recreational opportunities in rural communities. The city has identified the potential for a 3-mile long walking trail around the Ridge Creek Golf Course. This grant is a good opportunity to fund this project. Resolution No. 2021-50 authorizes staff to submit a grant application up to \$3 million for the Ridge Creek Pedestrian and Bike Interpretive Trail project.

OUTSTANDING ISSUES

None.

DISCUSSION

The City has identified the potential for a walking trail around the Ridge Creek Golf Course. The proposed trail was included in the recently updated Parks & Recreation Master Plan based on community feedback. This type of amenity also meets the city's goal of expanding access to recreational opportunities that enhance the quality of life for the community.

The city identified a state grant program that would potentially fund the trail. The state Rural Recreation and Tourism (RRT) Grant Program funded by Proposition 68 provides grants of up to \$3 million to rural communities that lack of outdoor

recreation opportunities. The city is working with a landscape architect to prepare a conceptual design for the trail. A key component of the grant requirements is to include interpretive elements as part of a project that highlight native plant or animal species or cultural history.

Staff will be conducting outreach with the Ridge Creek Estates Homeowners Association as well as the community at large. Once the conceptual design is completed, staff will present the design to the City Council for review and input.

The grant application deadline is November 5, 2021. Staff is requesting that the City Council adopt Resolution No. 2021-50 authorizing staff to submit an application in the amount of \$3 million for the Ridge Creek Pedestrian and Bike Interpretive Trail. A copy of the resolution is enclosed as Attachment 'A'.

FISCAL IMPACT

No matching funds are required. However, engineering costs may be required if awarded.

PUBLIC HEARING

None required.
