Subject: Resolution 2020-17 Road Repair and Accountability Act (SB1) Proposed Project List (JW)

RECOMMENDATION

Council adopt Resolution 2020-17, approving the SB1 proposed project list to be included in the Capital Improvement Program (CIP), as prescribed, to satisfy the program objectives and statutory requirements of the Road Repair and Accountability Act of 2017 (SB1).

EXECUTIVE SUMMARY

Senate Bill (SB) 1, which is known as the Road Repair and Accountability Act of 2017, provides additional funding through a combination of taxes and fees for the purpose of addressing basic road maintenance, rehabilitation and critical safety needs on the State's roadway network.

The anticipated amount of funding for fiscal year 2020-21 that the City will receive is \$478,366.00. As part of the requirements, cities and counties must submit to the State a proposed project list with various project details. The project list must be accompanied by a Resolution adopted by the City Council. This staff report will satisfy the funding and reporting requirements.

OUTSTANDING ISSUES

None

DISCUSSION

On April 28, 2017 the Governor signed Senate Bill (SB)1 (Chapter 5, Statutes 2017) which is known as the Road Repair and Accountability Act of 2017. To address the basic road maintenance, rehabilitation and critical safety needs on both the state highway and local streets and road system, SB1 will:

- Increase per-gallon fuel excise tax;
- Increase diesel fuel sales taxes and vehicle registration fees; and
- Provide for inflationary adjustments to tax rates in future years.

The State Controllers will deposit various portions of this new funding into the newly created Road Maintenance and Rehabilitation Account (RMRA). A percentage of this new RMRA funding will be apportioned by formula to eligible cities and counties pursuant to Streets and Highways Code (SHC) Section 2032 (h) for basic road maintenance, rehabilitation, and critical safety projects on the local streets and roads system.

In order to be eligible for this funding, recipient cities and counties must:

- Develop and submit a list of projects to the California Transportation Commission (CTC) each fiscal year.

- Fiscal year;
- Develop and submit a project expenditure report to the CTC each fiscal year; and
- Comply with all requirements including reporting requirements for RMRA funding.

The Dinuba Capital Improvement Program (CIP) budget will be adopted this year as part of the annual budget process. The estimated revenue increase from SB1 will be accounted for in Fund 207, Road Repair and Accountability Act 2017 (SB1). The RMRA funds will be distributed to the City in much the same way that the Gas Tax revenues currently are.

The RMRA program guidelines are intended to provide cities flexibility and discretion in selecting the needed road rehabilitation projects within their Cities. Therefore, it should be noted the City is not obligated to adhere to the submitted project list and has full discretion to amend or revise the list of projects as needed.

FISCAL IMPACT

The City is submitting a project list that exceeds the estimated SB1 allocation for FY 2020-21. However, the identified costs are estimates only and only projects that are within budget parameters will be funded. As noted above, the City expects to receive \$478,366.00 in total revenues for FY 2020-21 from the State's Road Maintenance and Rehabilitation Account (RMRA).

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DINUBA ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2020-21 FUNDED BY SB-1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017, ON BEHALF OF THE CITY OF DINUBA

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 28, 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of Dinuba are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City of Dinuba must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City of Dinuba, will receive an estimated \$478,366.00 in RMRA funding in Fiscal Year 2020-21 from SB 1; and

WHEREAS, this is the fourth year in which the City of Dinuba is receiving SB 1 funding and will enable the City of Dinuba to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City of Dinuba has acquired suggestions from the public and City Council to ensure public input was incorporated into the City's transportation priorities; and

WHEREAS, the funding from SB 1 will help the City of Dinuba maintain, rehabilitate, and/or reconstruct roads throughout the City of Dinuba this year and similar projects into the future; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

WHEREAS, for the purposes of transparency of reporting, it is necessary to appropriate the funding for the Nebraska and Crawford Avenue Reconstruction, Crawford Avenue Reconstruction, and the Street Sealing Project at various locations.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Dinuba hereby takes the following actions:

RECOMMENDATION

Council authorize the donation of surplus items to Community Life Garden.

EXECUTIVE SUMMARY

Community Life Garden is a non-profit organization that benefits local communities by promoting healthy lifestyles, self-reliance and community giving through gardening activities and educational programs. As a non-profit organization, Community Life Garden relies on donations to fund a large part of their operations. Staff has identified some items that have either exceeded their useful life or are not needed for City operations. These items can be donated to Community Life Garden to support their Programs that are available to Dinuba residents.

OUTSTANDING ISSUES

None.

DISCUSSION

The Community Life Garden (CLG) is a 501(c)3 nonprofit organization located on the southwest corner of Manning and Crawford Avenues. This organization is developing a membership nonprofit where members can use garden plots on an annual basis and have opportunities to learn how best to grow a garden, cook healthy meals, and contribute the fruits of their labor to family, friends, neighbors, church and the community.

As of January 2020 the CLG has built 25 garden plots, three benches and one shade structure. According to CLG estimates, there is a potential for up to 120 raised garden plots in their current site. However, as a nonprofit organization CLG heavily

relies on volunteers and donations for their operations. Given the worthwhile objectives of this organization, Staff has identified the following items that could be donated:

- 2 - 250 gallon water tanks
- 122 - 4"X4" wooden posts

These items have either exceeded their useful life or are not necessary for City operations. Staff supports these items being donated and recommends that Council authorize this action.

FISCAL IMPACT

The value of the items proposed for donation is negligible considering that they have exceeded their useful life or are of little operational use.

RECOMMENDATION

Council appoint four individuals to the Dinuba Public Safety Commission.

EXECUTIVE SUMMARY

The Public Safety Commission currently has four (4) vacancies on a five-member board serving at-large. The seats have been vacant for several months prohibiting the Commission to conduct business. Staff received four (4) applications for the vacant seats, and is requesting that the Council appoint the individuals to the Commission.

OUTSTANDING ISSUES

None.

DISCUSSION

The Public Safety Commission is a five-member board made up solely of at-large seats. There is currently only one seated member on the Commission. The Public Safety Commission has not conducted business for several months due to a lack of quorum.

The City Clerk previously has published notices in the local periodical and notifications have been circulated on social media to advertise the need for commissioners. The application for each nominee is enclosed herein as Attachment 'A'. The City Clerk received four applications for appointment to the Public Safety Commission. The application is enclosed herein as Attachment 'A' for the following interested individuals:

- Johnny Rodriguez
- Victorio Rojas
- Sherry Chavarria

- Paul Espinoza Jr

The City's Commission Appointment Policy directs that appointments be made to fill vacated seats where terms have not yet ended. Therefore, staff recommends that the seats be filled accordingly. The commission currently has three (3) seats with terms ending December 2020. The term of the fourth seat ends December 2021 to fill Commissioner Millard's term.

Staff recommends that the City Council appoint the following applicants to the Public Safety Commission accordingly. Although the commission membership is at-large, applicant Sherry Chavarria currently resides in Council District 3*, therefore staff recommends, for the mere purpose of simplicity, that Council consider appointing the applicant to fill the remainder of the term vacated by Commissioner Millard whom also resided in District 3. It is interesting to note that the other applicants each reside in different Council districts so there is good representation of the constituency even though the commission is a board appointed at-large.

Subject: Resolution No. 2020-16 Annual Review and Adjustment to Fees, Charges and Fines (KS)

RECOMMENDATION

Council conduct a public hearing and adopt Resolution No. 2020-16 implementing the recommended fees and fines effective July 1, 2020.

EXECUTIVE SUMMARY

In July 1992, the City Council adopted Resolution No. 92-31 establishing a fee and charge for services as part of cost recovery plan. These fees and charges are reviewed annually and adjusted as warranted. The proposed fees enclosed herein as Attachment 'B' include minor adjustments to reflect increased cost of providing services.

OUTSTANDING ISSUES

None.

DISCUSSION

The City established several fees and charges for a variety of general services, such as parks and facilities rental, police, fire and ambulance, public works, engineering, planning and building. In addition, the City adopted impact fees to mitigate the cost of needed infrastructure to serve new development. On September 25, 2018, council approved Resolution number 2018-52 approving an adjustment to Development Impact fees.

Adjustments to the fees for general services are evaluated and adjusted based on the U.S. consumer price index (CPI). Staff is recommending that these fees be

adjusted consistent with the 2019 CPI of 2.3%, with the exception of the following:

- Community Services – added the charge for Team Sponsorships in Youth Services (#17) of \$250 per team.
- Community Services – added two items, City Sponsored Activities/Tournaments (#10) for \$5 per person and Public Facility Rental (#11) for \$125 per hour.
- Police Services – added the charge for Crime Scene Photo Reproductions (#49) for \$1 per copy.
- Development Impact fees, staff is proposing to keep the rates at the same levels as approved on September 25, 2018.

The fees, if adopted, will take effect July 1, 2020.

FISCAL IMPACT

The proposed fee adjustments will provide for revenues consistent with the 2019 U.S. CPI.

PUBLIC HEARING

A notice of the hearing was published in the Dinuba Sentinel and in the City's Website.

WHEREAS, Resolution 98-08, adopted by the City Council on March 24, 1998, did declare the intent of the City Council to be that all fees, charges, and fines included in this schedule be reviewed at least annually and adjusted accordingly; and

WHEREAS, all requirements of California Government Code Sections 66016 and 66018 are hereby found to have been complied with;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DINUBA, CALIFORNIA, DOES RESOLVE, DETERMINE, AND ORDER AS FOLLOWS:

The changes to the fee schedule enclosed herein as Exhibit 'B' shall be in effect commencing July 1, 2020, and shall remain in effect until change or amended by the City Council. All other existing and approved fees, charges and fines will remain at their approved rates.

RECOMMENDATION

Council conduct a hearing to receive testimony concerning Application No. 2020-01, close the hearing and take the following action by one motion:

1. Adopt Resolution No. 2020-18 amending the General Plan Land Use Map from "Public-Semi-Public" to "Commercial Neighborhood."
2. Introduce and conduct the first reading, waive reading in full, of the Ordinance No. 2020-02 amending the City of Dinuba Zoning Map from "Resource Conservation" (RCO) to "Neighborhood Commercial" (C-1).

EXECUTIVE SUMMARY

This item is a request that the Council conduct a public hearing to consider a General Plan Amendment/Zone Change per Application No. 2020-01 (Amed). The subject property is located at the northwest corner of East Magnolia and California Street.

OUTSTANDING ISSUES

None.

DISCUSSION

The project is a proposal to change the zoning and land use designations of two parcels at the northwest corner of East Magnolia and California Streets. The location is the site of the existing Magnolia Market, and the applicant intends to tear down the building and construct a new market to better meet their needs and to conform to current codes.

The site is currently zoned RCO (Resource Conservation). Adjoining parcels to the north, west and south are also zoned with this designation. On the General Plan land use map these parcels are designated "Public-Semi Public". Lands to the west and south are owned by the school district and are used for the District's maintenance facilities, including transportation (bus yard). Land to the southwest is occupied by Dinuba High School.

At one time the District envisioned expanding the maintenance facilities onto the subject site (and parcels to the north). However, since the new high school was approved (at the southwest corner of Alta Avenue and Kamm Avenues) this is no longer the case.

At this time the applicant has expressed their interest in constructing a new market on the site and upgrading parking. This requires a zone change, as markets are not a permitted use in the RCO zone. The applicant originally requested the C-2 (Downtown Commercial) however this zone is intended for parcels within the downtown core (generally located to the west). Staff suggested application instead of the C-1 (Neighborhood Commercial) zone. According to the Zoning Ordinance the C-1 "is intended primarily for the provision of retail and personal service facilities to satisfy the convenience goods needs of the consumer relatively close to residential neighborhoods".

The C-1 zone also limits potential activities to a smaller list of permitted uses (compared to the C-2 zone). This could be important in case redevelopment of the market does not occur and other uses are proposed in the future. In this sense the C-1 zone would be more compatible with the surrounding neighborhood.

If the zone change is approved, staff will work with the applicant to achieve a site plan design for the market that functions well and enhances the neighborhood.

Environmental Analysis

Staff recommends the action be exempted from environmental review under CEQA (California Environmental Quality Act). This is primarily because the zoning is simply being changed to fit the actual existing use of the site. The site is already fully developed (with a market) and is proposed to be redeveloped in a fashion that will be more environmentally sound. The new market will be required to comply with current building codes so that it will be more energy-efficient (reducing energy use and air pollution). Further, water use may be reduced as the facility will be required to install low-flow fixtures (toilets, etc.).

Based on these concerns staff believes the project is eligible to be exempted from environmental review consistent with Section 15061 b 3 (General Exemption) of the Guidelines of the California Environmental Quality Act (CEQA). This Section states that "the activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it

can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.”

The Planning Commission conducted a public hearing on March 3, 2020, to consider the application. No comments from the public were submitted on the matter. Following discussion the Commission voted unanimously to recommend approval of the General Plan Amendment and Zone change.

FISCAL IMPACT

None.

PUBLIC HEARING

As required by the Dinuba Municipal Code, staff mailed notices of the proposed action and public hearing to property owners within 300 feet of the site, and tenants within 100 feet of the site. Staff also published a legal notice of the hearing in the Dinuba Sentinel in a timely manner. As of the writing of this staff report, no inquiries had been made.

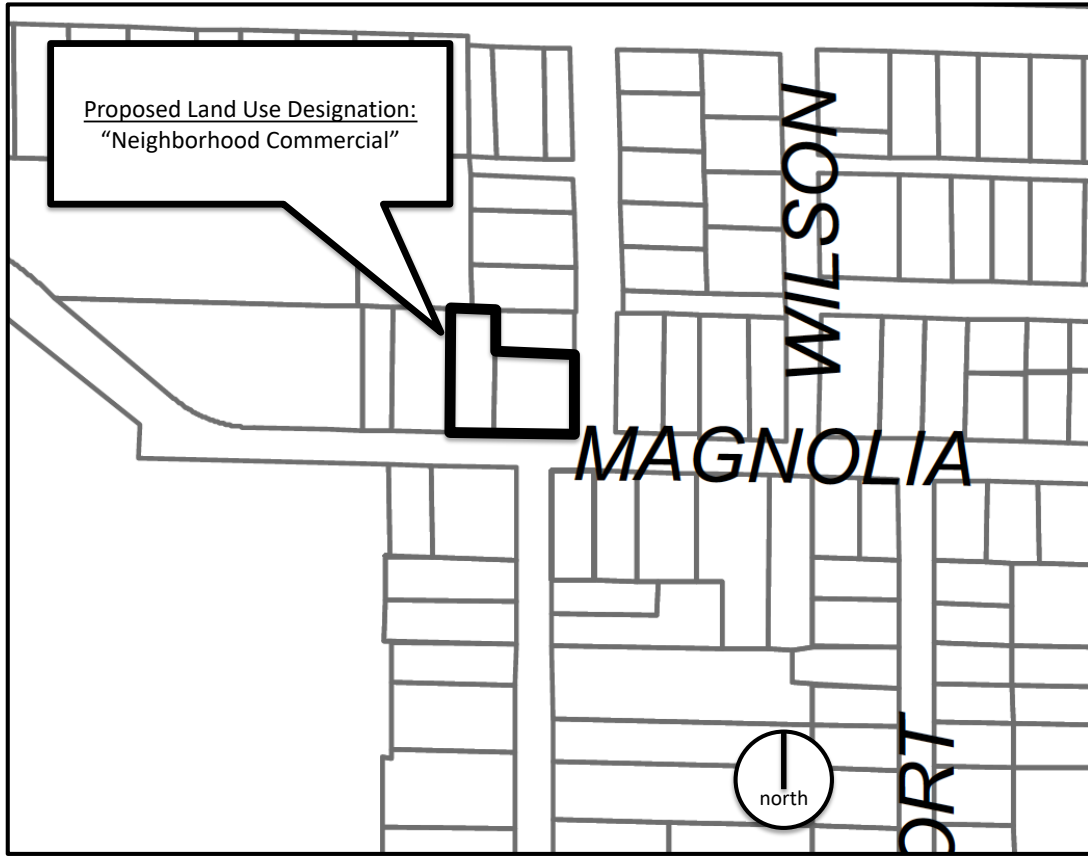

ORDINANCE NO. 2020-02

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DINUBA AMENDING THE ZONING OF PARCELS LOCATED ON THE NORTHWEST CORNER OF E. MAGNOLIA WAY AND CALIFORNIA STREET.

THE CITY COUNCIL OF THE CITY OF DINUBA HEREBY DOES ORDAIN:

SECTION 1. FINDINGS.

- (a) The City of Dinuba administers a Zoning Ordinance (Title 17 of the Dinuba Municipal Code), including a map that designates all parcels of land with specific zoning classifications.
- (b) The purpose of zoning is to facilitate a well-planned City and to avoid land use conflicts, among other objectives.
- (c) The City has received an application to amend the Zoning of specific parcels located at the northwest corner of E. Magnolia Way and California Street. Currently the parcels are zoned RCO (Resource Conservation). The parcels are proposed to be zoned C-1 (Neighborhood Commercial).
- (d) The Assessor Parcel Numbers of the subject parcels are 018-051-007 and 018-051-006.
- (e) The purpose of the zone change is to enable the parcels to be redeveloped with a new convenience market.
- (f) The proposed zone change is shown on Map 1.

SECTION 2. SEVERABILITY.

Each of the provisions of this ordinance is severable from all other provisions. If any article, section, subsection, paragraph, sentence, clause or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance.

SECTION 3. The City Clerk is hereby directed to cause a summary of this Ordinance to be published by one insertion in a newspaper of general circulation in the community at least five (5) days prior to adoption and again fifteen (15) days after its adoption. If a summary of the ordinance is published, then the City Clerk shall cause a certified copy of the full text of the proposed ordinance to be posted in the office of the City Clerk at least five days prior to the

Council meeting at which the ordinance is adopted and again after the meeting at which the ordinance is adopted. The summary shall be approved by the City Attorney.

This Ordinance shall take effect and be in full force thirty (30) days from and after its adoption.

SECTION 5. The foregoing Ordinance No. 2020-02 was introduced at a regular meeting of the City Council of the City of Dinuba on the 14th day of April, 2020, by the following vote:

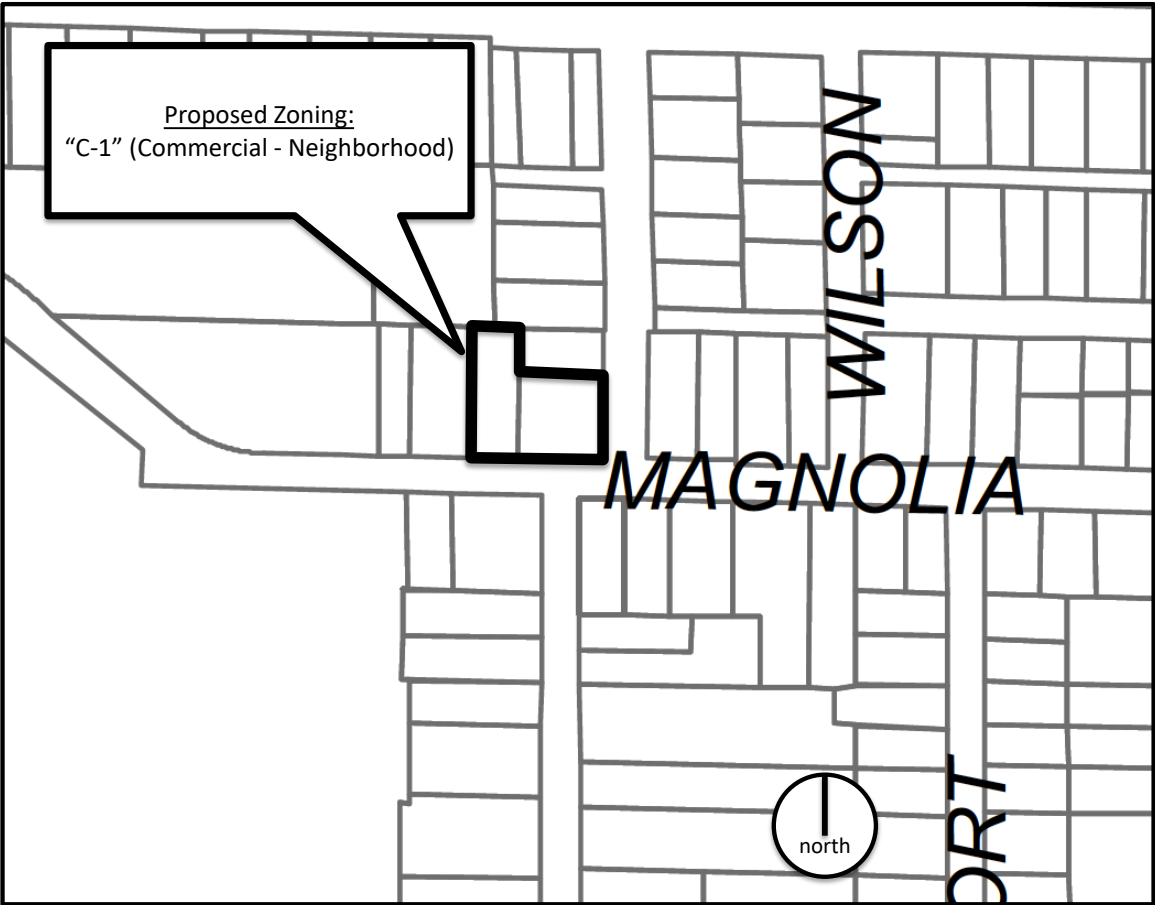

RECOMMENDATION

Council to receive informational update regarding Covid-19 pandemic and provide direction to staff as necessary.

EXECUTIVE SUMMARY

The city continues to closely monitor events related to Covid-19 pandemic. The Governor's stay and home executive order was extended to May 1, 2020. The number of cases in California have slowed slightly with the peak expected to be in May. Tulare County continues to experience increases in cases as more testing is done and hot spots are detected.

OUTSTANDING ISSUES

None.

DISCUSSION

The Covid-19 pandemic has resulted in the Governor issuing an executive order on March 19 for all California's to stay at home and for non-essential businesses to shutter through May 1. The County of Tulare and all cities in Tulare County have declared local state of emergencies in response to Covid-19 pandemic.

City offices have been closed to the public in order to protect employees and the public from spreading the disease. The city's emergency operations center has been activated and meetings are held regularly in order to be prepared to respond to any issues that arise during the crisis. Staff has been in close communication with Tulare County Office of Emergency Services and Tulare County Health and Human Services Agency regarding updates on the number of cases and protocols for protecting the public.

City staff has been doing a good job carrying out their routine duties during this crisis. Fire and police personnel continue to provide emergency services to the community with the use of personal protective equipment as needed. Each department continues to evaluate operations on a daily basis and adjustments are made in an effort to protect employees and the public from the spread of the virus. The city has also provided updates and resources via social media and a dedicated webpage with helpful information on Covid-19.

These are challenging times. The fallout of the Covid-19 crisis is unknown. Much depends on the length and severity of the crisis. The federal and state government has created and funded a variety of programs aimed at providing financial assistance to individuals and small businesses impacted by Covid-19. Additional stimulus is being considered by Congress, but timing and details are unknown at this time.

Staff will continue to closely monitor county, state and federal actions related to Covid-19 and provide updates to the City Council and the community as information is received.

The fiscal impact is being continuously monitored to keep abreast of issues that may arise.
